Collin, Leonard, Texas. The meeting will be held for the purpose of receiving community input on the Budget, which will cover the Fiscal Year beginning October 1, 2018 and ending September 30, 2019.

"This budget will generate less revenue from property taxes than last year's budget by an amount of (\$64,982.08), which is a (13.36%) percent decrease from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$7,073.47."
