- 2. Public Hearing 2019-2020 Proposed Budget**

The City Council for the City of Leonard, Texas will hold one public hearing on the 2019-2020 Fiscal Budget of the City of Leonard, Texas on Tuesday, September 3, 2019 at 5:30 p.m. in the Council Chambers at the City Hall, 111 W. Collin, Leonard, Texas. The meeting will be held for the purpose of receiving community input on the Budget, which will cover the Fiscal Year beginning October 1, 2019 and ending September 30, 2020.

*"This budget will generate less revenue from property taxes than last year's budget by an amount of - \$26,752 which is a -4.7186 percent decrease from last year's budget The property tax revenue to be raised from the new property added to the tax roll this year  $\$9,505 = (0.5195 \times \$1,829,650) / 100$ . The debt levy to be raised from new property added to the tax roll this year is:  $\$2,662 = (0.1455 \times \$1,829,650) / 100$ "*
