1. **Invocation**

The invocation was led by Adam Spore.

2. Pledge to the United States and Texas Flag

Mayor called upon Eden Poppelrieter to led the pledge of the United States and Texas Flag.

3. Call to Order

Mayor Bolin called the meeting to order at 5:30 p.m. with a quorum of five councilmembers.

4. Proof of Posting of Notice of Meeting – City Secretary

Mayor Bolin noted the proof of posting of meeting by City Secretary.

5. **Verification of Quorum**

Mayor Bolin noted the quorum of five councilmembers were present.

6. Citizens Forum: (State law prohibits the City Council from considering or deliberations on any item not listed on the posted City Council agenda. A person may address the Council on items not on the printed agenda. Comments are limited to three (3) minutes. The Council may not comment or deliberated regarding such statements or comments during this period. Any discussion of the subjects must be limited to a proposal to place the subject on the agenda for a future meeting. Sec. 551.042 of Open Meeting Act). Eddie Suddeth addressed the Mayor and Council and informed them that he had sold the property at 201 N. Connett. The new owner will begin restoration of the property beginning next week.

Leonard Phillips made the motion to obtain bids (one than one) for the repair of the building including the façade and windows on the second floor. Jane Blackerby seconded the motion. Motion carried, 3-2. Billy Grimes and Bob Pannkuk opposed the motion.

Jane Blackerby reminded the Council of the Christmas Parade on December 3rd, 2016.

City Administrator, Jim Cox reported to Council that Public Works was working on the Christmas lights on the building and more lights had to be ordered. He recommended that the lights on the buildings be turned on prior to Thanksgiving. The City would decorate the tree in the front for Christmas and possible have a lighting of the tree with caroling prior to the Christmas parade. It was noted that was the "Mayor's Christmas Tree".

Leonard Phillips questioned if an outside water district was coming into the city's water district. Jim Cox City Administrator announced to the Council that the city had received a \$3,500.00 grant from Texas New Mexico Power for a fountain to be placed in the pond in the park. This fountain would be a great asset to the pond and park.

Billy Grimes noted that there was a flyer out on the Christmas Parade.
